

## COVID-19 Participation Waiver-Crystal Lake Strikers Inc., NFP - Adult Strikers 2021 Season

I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities recommend practicing social distancing. I further acknowledge that the The Crystal Lake Strikers Drumline, Inc. NFP ("Strikers") have put in place preventative measures to reduce the spread of the Coronavirus/COVID-19, based upon the recommendations of the CDC and public health authorities.

I further acknowledge that the Strikers cannot guarantee that program participants will not become infected with the Coronavirus/COVID-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, instructional staff, members of the Strikers, other event participants, and their families.

I voluntarily seek services provided by Strikers to participate in the Strikers program, and acknowledge that program participants increase their risk of exposure to the Coronavirus/COVID-19. I acknowledge that program participants must comply with all set procedures to reduce the spread while attending a Strikers sponsored rehearsal or event.

*I attest that:*

- 1. The participant, at the time of participation or at any time during the preceding 14 days, is not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.*
- 2. The participant has not traveled internationally within the last 14 days.*
- 3. The participant has not traveled to a highly impacted area within the United States of America in the last 14 days.*
- 4. The participant does not believe they have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.*
- 5. The participant has not been diagnosed with Coronavirus/COVID-19 or has been cleared as non-contagious by state or local public health authorities.*
- 6. The participant is following all CDC recommended guidelines as much as possible and limiting their exposure to the Coronavirus/COVID-19.*
- 7. The participant will adhere to the participation policy set forth by Strikers and the instructions that are given before, during, and after Strikers sponsored events by board members, instructional, or volunteer staff.*

I hereby release and agree to hold Strikers, its volunteers, staff, board members, and representatives, harmless from and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in any way in connection with any services received from or participation in any Strikers program or event. I understand that this release discharges the Strikers, its volunteers, staff, board members, and representatives from any liability or claim that I, my heirs, my family, or any personal representatives may have against the Strikers, its volunteers, staff, board members, and representatives with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from a Strikers program or event. This liability waiver and release extends to the Strikers together with all board members, instructional staff, and volunteer staff.
